

WAIVER FORM

1. I, the Participant signing below, have read the Standard of Conduct for The Battlezone (or it has been explained to me and I understand it) and I agree to follow it.
2. I understand that:
 - a. If I fail to follow any rule in the Standard of Conduct, I may be required to leave the game without a refund.
 - b. A warning may, but need not be given before I may be expelled from a game for a rule violation. If I chose for any reason to withdraw from a game, I will not receive a refund.
3. I understand that:
 - a. The games at Battlezone may involve dangerous body contact with other people or objects and that I need to be careful, keep myself safe, and avoid hurting others.
 - b. I could be seriously injured because of my own negligence or the negligence or willful misconduct of others, including Battlezone, any of its owners, employees, parties providing goods or services to Battlezone or the owner of the premises ("Battlezone parties").
 - c. Injuries could include bruises, cuts, broken bones or worse, and could include psychological injury or trauma.
 - d. I assume all risks of participating in games at Battlezone.
4. In consideration of being permitted to use Battlezone's facilities, I agree that:
 - a. Neither I nor any of my representatives (including any spouse, or my heirs or my estate), will sue or in any way file any claim against any Battlezone parties.
 - b. I (or my estate) will hold all Battlezone parties harmless from and indemnify them against any lawsuits, claims, damages of any kind, expenses or costs in any way related to any injury I may suffer (or my death).
 - c. In the event of sickness, accident or injury, I authorize Battlezone or its employees or representatives to obtain emergency medical treatment for me at my expense.

I understand that under this Agreement and Waiver I give up important legal rights. I am giving up these legal rights voluntarily in order to participate in games at Battlezone.
